Sub: School Education - Directorate of Private Schools - Tamil Learning Act, 2006 - Sub Clause (iv) of Clause (e) of Section 2 - Schools affiliated to various Boards other than State Board of School Education - Tamil shall be a Subject of taught - further administrative actions - to be formulated - regarding

As per the G.O 2nd cited Government ordered that "Tamil shall be taught as a subject in Standards I to X in all schools notified under sub clause (iv) of clause(e) of section 2 of the Tamil Nadu Learning Act, 2006 (Tamil Nadu Act 13 of 2006) in a phased manner commencing from the academic year 2015-16 for standard I, from the academic year 2016-2017 for standard I and II and shall be extended up to standard X in a like manner" as shown below:-

From the Academic Year	For Standards
2015-2016	I
2016-2017	I & II
2017-2018	I, II & III
2018-2019	I, II, III & IV
2019-2020	I to V
2020-2021	I to VI
2021-2022	I to VII
2022-2023	I to VIII
2023-2024	I to IX
2024-2025	I to X

Therefore, by the end of the next academic year 2024-2025, all Private Schools affiliated to various Boards other than State Board will have to ensure that all students from classes I to X be taught Tamil. Those students who opt for Tamil as one of the languages in classes IX and X as part of their respective Board Exam requirements can continue to do so. However, those students in classes IX and X who have not opted for Tamil as one of the languages as part of their

respective Board Exam requirements will have to be mandatorily taught Tamil as an additional compulsory language.

The Director of Private Schools will determine the syllabus as well as the exam pattern for the same. The final written examination for this Tamil Paper for Class X for all Private Schools will be conducted by the Director of Government Examinations, Tamil Nadu and a separate certificate will be issued for the same.

Private School managements must employ suitable fully qualified teachers to teach Tamil effectively to students. Periodical examinations / tests as conducted at school level for other subjects should also be conducted for Tamil subject for students. The District Educational Officers (Private Schools) shall monitor and ensure that Tamil is taught by the qualified teachers in all schools that come under their jurisdiction.
