Notes:

1. Students wishing to join in April would need to pay an Immersion Programme Fee (for April & May) in addition to the annual school fees.
2. The Composite School Fee does not include examination fee for all IB programmes and external examination, stationery, text books, uniforms, annual production charges, annual camps, additional subject support/individual learning support (if applicable), off campus sports/ activities, specialized individual projects in Design & Technology/ Visual Arts/ Sciences.
3. CP: Career-related studies will be paid directly to the Career-related studies provider via the online payment link shared over mail.
4. To meet the expenses towards Annual Camp, Photograph etc., all students are required to maintain a Contingency deposit of ₹ 20,000. The amount needs to be topped up quarterly to the required level.
5. Family concession (for children of same parents) for siblings.
 - a) 50% security deposit exemption for second sibling and 100% exemption for third sibling.
 - b) 50% rebate for sibling for Transport Fee.
6. Fee Payment Options:-
 - a. Annual Payment Upfront : Payable by 10th August
(This will carry 5% rebate on Composite fee only if all fee components for the entire year are paid upfront)
 - b. The composite fee is charged for a full academic year (12 months) and is payable in four quarterly instalments: August–October, November–January, February–April, and May–July.
 - c. Fee Payment in four installments:

| Second | For November – January | 10th November |
| Third | For February – April | 10th February |

7. **Late Fee Payment Penalty** - If the fee is not paid by the stipulated date, a late fee of Rs.100/- per day (including holidays) will be charged. A maximum of 30 days period after due date will be given with late fee fine thereafter it will result in cancelled of admission automatically. **Bank charges / Late Fee**, if any, shall be deducted from the student contingency account and no additional **communication through email or call will be sent for the same if fee paid through NEFT after due date.**
8. Parents/Guardians shall be solely responsible for any consequences arising out of the non-payment of the school fees on time.
9. Non – compliance to payments procedures can affect the student's enrollment in the school and the pending fee will be adjusted against the security deposit.
10. Request for withdrawal should be submitted latest by 31st October for end of first term withdrawal or latest by 31st March for end of year withdrawal.
11. The School Management reserves the right to amend the Fee structure and rules/policies annually without prior notice.
