This is to inform you that as per the latest guidelines issued by CBSE regarding the **Second Board Examination for Class X (2026)**, the process for submission of the **List of Candidates (LOC)** and payment of examination fees will be conducted as per the schedule below:

**Schedule**

Activity	Schedule
Examination Fee payment- 1 <sup>st</sup> Phase	<b>16.04.2026</b> -(around Noon) to <b>20.04.2026</b> .
LOC Submission-and Examination fee payment - 2 <sup>nd</sup> Phase	<b>16.04.2026-20.04.2026</b> .
LOC Submission- and Examination Fee payment 3 <sup>rd</sup> Phase with late fee	<b>21.04.2026-22.04.2026</b>

**Important Points for Parents & Students**

1. Students who wish to appear in the **Second Board Examination** but were not registered in the First Phase for the Improvement Exam, can now submit their names and pay the examination fee by **18<sup>th</sup> April**.
2. Students already registered in Phase 1 need to **complete the fee payment** within the given timeline.
3. Students who do not wish to appear in the Second Examination may **withdraw their candidature**.
4. Students have the option to **change their Mathematics subject level**:
  - o Those who opted for **Mathematics (Standard)** may switch to **Mathematics (Basic)** for the Second Examination.

- Kindly confirm your ward's participation and complete the **fee payment by April 18<sup>th</sup> 2026**
- For the CBSE Class 10 Second Board Examination 2026, the examination fee is ₹320 per subject with fees for three subject's totalling ₹960.
- Ensure that all details are submitted accurately to avoid discrepancies and late charges.
